HANDY'S HISTORY

In 1985, a gentleman from the *Guardian ad Litem* Program, Ed Pudaloff, won the JCPenney Service Award for \$1,000. He decided that he wanted to create something special to help abused and neglected children in the Broward County community. He reached out for help to two of his closest friends, Marti Huizenga and Kathy Jackson.

The three of them started three different fundraising committees and were able to create scholarship funds, buy clothes for the children and celebrate childrens' birthday parties. In the beginning, they had two well-known events that went on for years: Easter for Kids and the Fashion Show before expanding to include Prom Night and the Scholars Breakfast.

This year, we want to recognize all of our important founding members and the impact that their vision for HANDY continues to have on our community.

ABOUT HANDY

HANDY stands for Helping Abused Neglected Disadvantaged Youth.

HANDY's mission is to achieve positive, lasting change for youth by providing life skills, education and a supportive community.

HANDY is an award-winning 501 (c) (3) non-profit organization. Since HANDY's founding close to 35 years ago, it has touched the lives of more than 45,000 Broward County children in foster and relative/nonrelative care associated with the child dependency system.

In 2012, HANDY became the first social service agency affiliate of Scholarship America's Dollars for Scholars program, allowing national exposure for HANDY's Scholars program which gives national exposure to HANDY'S Scholars program, that provides education case management and financial support to students.
